RECOGNISE:

- The important work former President Thabo Mbeki did in bringing broader awareness to the challenge of Illicit Financial Flows (IFF).
- That IFFs pose a serious threat to Africa's socio-economic transformation and the achievement of United Nations Sustainable Development Goals (SDGs) (Agenda 2030).
- That accountability is critical in attaining Africa Agenda 2063, which provides impetus and direction to Africa's development.
- The strategic value of Supreme Audit Institutions (SAIs) in enabling oversight and public accountability.

- Messages of support made by various PAC regional associations.

EMPHASIZE:

- The need for AFROPAC to continue mobilizing other nations that are not yet members of AFROPAC.
- The importance of PAC regional associations to continue playing a facilitative role in ensuring the successful implementation of AFROPAC programs.
- The need for AFROPAC to continue to seek strategic partners to assist in achieving its strategic objectives.
- The need for Member Countries to take ownership and demonstrate commitment to the pursuance of AFROPAC's objectives in line with Africa Agenda 2063 (Continental Resource Mobilization).

VALUE:

- The need for deepened institutionalization of political accountability as a launching pad for greater oversight and good governance in Africa.
- The desire for a coordinated continental approach to find solutions to Africa's problems and challenges.
- The need for continued collaboration between PACs and SAIs towards enhanced democracy and accountability.
- The need for legislative reforms to empower oversight institutions in dealing with diverse challenges experienced in different countries.

WE THEREFORE DECLARE:

- That all member countries shall institute processes to take forward the debate on IFFs to increase awareness.
- That AFROPAC prepares a draft resolution on IFF which member Parliaments must adopt.
- That AFROPAC coordinates the development of a continental framework to deal with matters of IFF.
- That AFROPAC engages AFROSAI in developing audit methodology for dealing with IFF.
- That AFROPAC and AFROSAI jointly identify possible cross-border projects for audit collaboration.
- That all member countries establish and strengthen mechanisms for prioritizing performance audits.
- That all member Parliaments develop legislative reforms that will enhance public financial management systems and enable surveillance, detection, and recovery of IFFs.
- That AFROPAC aggressively pursues a recruitment drive to ensure that all Parliaments of Africa become members.
- That AFROPAC produces a progress report advising on progress in the implementation of resolutions in six months.
- That AFROPAC shall establish a permanent Secretariat in Nairobi Kenya.
- That this General Meeting approves and adopts the Constitution of AFROPAC.
- That all member countries of AFROPAC pay an annual subscription fee of USD 5,000.
- That the next General Meeting be held in Addis Ababa, Ethiopia in August 2018.
